Records included in this search vary by state, and can include statewide convictions, arrests, court records, and inmate records from an array of sources including County Clerk of Court records county courts as well as statewide sources such as the Department of Corrections.

Records are continually expanding and building this national database on a daily basis.

The Criminal SuperSearch is recommended in a variety of circumstances, particularly when an applicant's Social Security Number indicates residence in several states and it is more cost effective to run the SuperSearch as opposed to a statewide or single county search in each state of residence.
